Don contacted Alan C to follow-up with the lawyer working on our 501C3 filings. After a month of calls the lawyer responded with a bill for \$368.00 and not much activity toward getting our By-laws ready for filing.

Don found a reputable service called legalfilings.com that quoted the following fees associated with preparing By-Laws and filing 501C3;

\$574.00 – Prep documents, review and amend, prep by-laws, respond to IRS inquiry, 554 Employer ID # and draft business plan.

\$460.00 - State filing fees

\$300 - 700.00 -Scale based on revenue

\$86.00 – NY State Tax Exempt Corporate Seal and Kit

Total Cost - \$1,120.00 - 3 - 7 Months for completion

Motion: To write a letter to the lawyer, working on the 502C3 filings, to terminate his services and negotiate a final payment. We are now going to use LegalFilings.com. **Motion Carried.**

Motion: To add \$700.00 to the total to pay for LegalFilings.com. **Motion Carried.**

A few issues must be addressed prior to committing to LegalFilings.com one is the official name that will appear on all 501C3 filings. Another is to stager the elections of officers to help with transition and continuance.

Motion: To use NYCMA Inc. as the official name on all 501C3 filings. Motion Carried

Motion: To stagger elections of officers keeping the current Secretary for a 3 month period, ending March 2007.

Motion Carried.

We need to establish a set process to comply with the 501C3 requirements. This will be discussed in more detail after Don begins working with LegalFilings.com. Some of the benefits we can expect as Non-For Profit with Tax Exemption is; Free Public Survive Announcements and Reduced postage.

The Chairman, Secretary, Treasurer and four Committee Chairman will be the new Board of Directors for NYCMA.
