# I. Treasurers Report -Bruce W

Bruce W shared that after expenses and revenue this past month, NYCMA has had a \$ -582 change in cash based primarily on the deposit expenditure for Friends Meeting House for Share-A-Day.

Bruce W made us aware that "against trend", our 7<sup>th</sup> tradition donations were lower for half FY 2015 than FY 2014, however, he does not think there should be any sense of crisis.

The treasurer's report was accepted by a 14-2 vote.

#### II. Structure and Finance –Brett S.

- Meeting occurred with Bob O and Jim H to review By-Laws—structural and grammatical inconsistencies discovered
- Suggestion to consider a late fall by-laws revision, PRECEDED by a September or October NYCMA group inventory regarding what changes are needed
- Suggestion to offer the inventory model to individual meetings if they are interested in identifying priorities they need from Intergroup
- Plans to contact Los Angeles and Phoenix CMA to learn more about their S&F and whether they use a 501(c)3 and board of directors
